


### V. Vice Chair Report – Tom Coyle

- a. Welcome Merideth Smith our new member to the Community Member seat. •

### VI. Interim Secretary Report – Tim Frost

- a. **Motion 1 – Passed**
- b. Thank you letter from Gates Ambulance for the support of the training we provided some funding for.
- c. Tim Czapranski and Tim Kelly are on the membership committee with Tim Frost. We are hoping for one more.
- d. Note on term dates: are March 31<sup>st</sup> not December 31<sup>st</sup> due to our fiscal/operational year.
  - i. The four officers are coming upon their term limits. After March 31, 2018 Tom Coyle will be termed out as Vice Chair, and three more will term out March 31, 2019.

**VII. Treasurer's Report – Mike Hoskins - Excused**

- a. Budget Adjustments for 2018 Budget Cycle
- b. Our accounting firm Raymond Wager is merging with our book keeping firm effective January 2018, which causes an issue for us. Wager will continue doing our audit and accounting for 2017, at which point we will need to conduct some RFPs for some better valued options.
- c. The State requires that we submit our annual budget for five consecutive years in 2015. We had put together the budget originally and have some challenges we are facing as we've identified some things we need to make budget modifications for in our Program Agency budget. The finance committee met earlier this week in order to take maximal benefit of everything. No action required on the Council's part, but over the next few years, some changes need to be made. We spend about \$9,000 out of our budget on book keeping and accounting out of our Council budget. We will be moving our website maintenance (~\$4,000/year) onto the Council budget from Program Agency, and we can research some alternate option. The Awards budget has been budgeted for \$600, but we are spending more (\$1,000). As we move forward, the trainings we have provided funding for, will be adjusted due to funds depending on vendors we find. Within the training budget, if we are unable to find any cost savings, we need to identify what is the per person benefit to the community before we spend that money. We need to identify things for EMS week – this costs us \$3,300. We need to discuss what we want to do to impact the largest number of folks in our community. Awards are important, so what can we do to adjust this? If you have any experience/ideas with either accounting firms or website options, discuss with Mike Hoskins so we can explore other options.
- d. Does this need to be voted on? No – we don't require a Council vote for modification of a previous budget. There would need to be a vote to decide on a different vendor. Hopefully we will have responses by our January meeting to then conduct the vote.
- e. Some other regions charge for credentialing, which might be something we want to consider offsetting some of these costs.

**VIII. System Medical Director – Jeremy Cushman**

- a. Rate Control Device Recall
  - i. Preliminary data research done at our office. ALS providers, please review and engage with your Medical Director.
- b. Pediatric BVM advisory
  - i. Decrease in the rate of overventilation. This is for you to discuss with your Agency Medical Director on whether you will be implementing this or not.
- c. Changes in naloxone formulation
  - i. Our office is no longer carrying the 2mg Naloxone syringes and mucosal atomizers. We are now only supplied with the 4mg Adapt Pharma Naloxone Nasal Spray. You will start seeing these more often. You cannot divide the dose in two nostrils, everything goes in one. This is a statewide change. Use what you have first. This supply is for BLS First Response (not ambulances). Encourage ambulances to continue to use the vials of Naloxone. Be aware of potential increase in vomiting with the larger dose nasal spray.

- d. Changes at the Bureau of EMS
  - i. Lee Burns is retiring at the end of the year. No identified heir apparent. Tom Behanna is also moving on.
- e. Ongoing statewide BLS protocol revisions
  - i. Draft has been submitted. More to come as things develop.
- f. Ongoing collaborative ALS protocol revisions
  - i. As you identify errors or things to improve the Collaboratives, please let us know.
- g. In Monroe County there are 500 MHAs a month. Met with MC LEC, a tag is being developed – how are we restraining these folks and how can we be consistent across law enforcement jurisdictions. Hope to engage Livingston County as well. If you are interested or have some expertise in this, please let Dr. Cushman know so we can include you.

### IX. Program Agency Report – Ben Sensenbach

- a. Training for Narcan Nasal Spray is now available on Cypherworx
- b. Payment has been approved for last quarter's Program Agency and Council Vouchers. There was quite the delay in payment, which is due to having our expenditures audited. There were no issues within the audit, and they also paid us a bit of interest.
- c. amfAR has not yet sent contracts for renewal. We are still able to provide Narcan Nasal Spray, but data tracking is currently unfunded.
- d. Working with BEMSAT to improve data validation to state data bridge.
- e. NYS DOH Actions
  - i. Gregory Monsky's NYS Certification was revoked after an investigation by the NYS DOH BEMSAT for violation of 10 NYCRR Part 800.16(a)(8). This provider did not practice in the Monroe-Livingston region.
  - ii. Vincent Ilardi's NYS Certification was revoked after an investigation by the NYS DOH BEMSAT for violation of 10 NYCRR Part 800.16(a)(8). This provider did not practice in the Monroe-Livingston region.

### X. Livingston County Report – Karen Dewar

- a. Has completed its transition to the windows based CAD. Smooth transition except for the redundant text messaging, but the bugs are being worked out. The Monroe County patch to Livingston County is complete. Honeoye Falls is the only agency currently on it, more are welcome.

**XI. Monroe County Report – Tim Czapranski**

- a. Last week we worked out Mutual Aid into the City of Rochester. So far that has been completed. Once a mutual aid policy has been made, we will bring that forward. We think it's important to bring these forward, so we don't delay this.
- b. Part 18 applications – process is that you send everything to the State, they send out your permit, the County Coordinator does not get your application information. Law Enforcement asked for this information for the Turkey Trot. As we move forward in 2018, I will ask that you submit it to the County Coordinator for distribution through Law Enforcement.
  - i. We want everyone on the trunk radio system. There are agencies that don't have the equipment at the stations to do this now. We will give them temporary radios to remove the patch sooner. (only 295)

**XII. REMAC – Elizabeth Murray, DO**

- a. Time of year again – Patient Safety Committee will be accepting applications in December.
- b. Received a request for Julie Jordan resignation as ALS Committee Chair. We will be reworking that committee in order to serve the needs of the region.





