Re: Advisory 12-01: CME Allocation Matrix for Original Standardized Course Offerings

At the January 16th meeting of the Monroe-Livingston REMAC, the [CME Allocation Matrix for Original Standardized Course Offerings](#) was approved.

The Allocation Matrix applies ONLY to ORIGINAL courses. CIC's may permit CME credits for recertification courses at their discretion, but at no time can a recertification class provide more than one-half of the CME credit that would be allowed for the full original class.

The purpose of the Allocation Matrix is to provide some guidance to NYS CIC's that manage CME-based recertification programs in our region. As such, the information contained in the document is a recommendation, not a regional mandate, and the CIC and/or Medical Director have ultimate responsibility for allocating CME credits for coursework.
