Program Agency Report – Tracy DeMarse

- As Reg mentioned, we have been in contact with NYS trying to track down about \$13,000
- As Mark mentioned, four providers have recently passed away
- We will bend over backwards to get information re: fundraisers, services etc. on the website and
 in the weekly e-mail, but we need to know about it. Please keep this in mind.
- We have to receive an official request for information to get posted; we are not being selective
- Quarterly reports were sent out for 4th quarter
- Will begin working on 1st Quarter report in a few weeks
- Have been contacting agencies to setup accounts in Image Trend, the NYS bridge for NEMSIS
 information
- EMS Charts users don't have to do anything
- The State would like 2 users per agency to have accounts; All but 3 agencies are now setup
- We have been contacted by a company called Train Lou an online repository subscription system for training videos for Fire & EMS
- They would like to access our videos to put in their library
- Before we can do anything, we need this body's approval
- An agency interested in working with them would have to pay for a subscription to have access to their online library
- Technically, they would be making money selling subscriptions to our free videos
- Our videos were created using State and Federal dollars not sure we can give these away to someone who is charging for the services
- Facebook page about ready to go a few things left to discuss
- You can't have a page without sponsored ads is this body okay with that?
- This is part of the cost of doing business Facebook doesn't cost us money
- The Fire Bureau has a Facebook page the ads are standard
- Motion to approve Facebook page even with ads, Second, All in favor? Discussion?
- Tracy will be the admin of the page; has ability to delete comments posted by others etc.
- All trainings, advisories, etc. posted to the page will be linked to the MLREMS website
- Once launched, we will make a plea to keep inflammatory comments of the page etc.

NEG Report - Reg Allen

- Motion to accept the 20th edition of the MLREMS by-laws effective September 17th except for section 2.03
- Membership as identified in section 2 of the 19th edition of the by-laws will remain in effect until December 31st
- On January 1st, 2013, section 2.03 of the 20th edition of the by-laws will become effective
- 2012 fall elections will be to fill membership outlined in section 2.03 of the 20th edition of the bylaws
- Second. Discussion?
- Question: is it appropriate to have two Livingston County seats? Do both represent the same interest? Discussion re: this issue.
- Council has been restrictive about not having agencies having more opportunities for one seat;
 don't want to diverge from that
- Change wording that say "any" CON holder for the county can hold that seat vs. "the" CON holder
- Secretary's job description & the records they maintain either the secretary holds the records or we contract it out to the Program Agency
- The only position that excludes EMS is the community position
- We aren't eliminating anyone; we reconfigured & organized the Council
- There will be a transition; it's not about who gets to stay. It's about the need to have our organization represented better

- We do not run background checks or credits checks on our members, however, we are handling State dollars, may be a good idea to look into doing this in the future
- Other discussion re: the motion on the table?
- Every time we post these by-laws for comments, we receive none, but when the meetings roll around, everyone has comments
- We have not made significant changes shouldn't have to repost the document for another 20day period
- Suggestion to move on with the vote

- Significant changes in terms of EMT curriculum requirements, as a result, one core sponsorship
 in particular has modified its present structure causing quite a stir
- That sponsorship is without complete leadership; Jen Levey has been stepping in to fill the void
- Asked Jen to step down as chair of this committee to eliminate any conflicts that already exist between her job role & the community at large
- Council is responsible to ensure that the training needs of our region are met

- Gap in the training opportunities for EMTs in our region
- Training & Ed needs to step forward in ensuring people in this region are receiving the product they need
- Poor attendance at Training & Ed
- Agencies do not have to send their providers outside of the MLREMS region to receive training
- We appreciate all of the work Jen put forth during her time as chair
- We are now looking for a new chair- interested parties should email Tracy or Mark
- Seconded motion to bring forward 2 CLI candidates
