IX. System Medical Director – Jeremy Cushman, MD

- Advisories have been released related to patient safety concerns.
- Clinical guidance has been issued on automated compression devices more of a best practice document. Once we have a critical mass of these out, we can look at implementing the ECLS algorithm (currently at the state for review)
- FAST-ED is now live. This was a collaboration between the Finger Lakes Region and ours, we hope that this will be the first of many collaborations.

 - "…Any person over two years of age and able to medically tolerate a face-covering must wear a face-covering when in public and unable to maintain social distance. Passengers over the age of two and able to tolerate a face-covering must wear a mask or face covering when on public transport or private for-hire transport. Drivers or other employees of transportation carriers must wear a mask or face-covering if there are paying passengers on such transport. Any employee present in the workplace must be provided a mask or face-covering and must wear it when in contact with customers or the public, or unable to socially distance. Business operators and business owners must deny entry and/or remove any person who fails to comply with the face-covering requirements. Adequate face coverings include cloth masks, surgical masks, N-95s, and face shields. To maintain social distance, persons must keep at least 6 feet away from any other person, other than their own family members…"

- All of your ePCR frustrations have been passed to the bureau. When we answer questions, we make sure to point out the level where the hangup is so that we can direct those issues to the right place.



- ED Diversions can only happen in four hour blocks. Most of these are outside of our region if we have a legitimate concern, we will keep an eye out for those that will impact us. Many of you recall the REMAC and our local hospitals ended diversion a decade ago as it is not patient centric. Areas that do it have more hospitals, it is not a viable solution to assist in hospital drop times or volumes because we only have four hospitals. We continue to monitor and have had discussions about it, but it is not wise at this moment.
- Are there repercussions if an ambulance shows up to a hospital on diversion? No, they are not closed, just requesting that you don't come there.

- CIU took place on 10/25/2021. We are still processing paperwork, the forms that were listed on the Bureau website were not correct.
- State has appointed two regional faculty members per county. We don't know who they are. If your instructors receive letters, please let us know. Brian Wiedman to look further into this.

• West Webster Fire District transfer of operation authority to Penfield Volunteer Emergency Ambulance application received. Working on a time to get the systems committee together, this means we need a council meeting in december 12/20.

- Bureau issued documents 21-07 and 21-08 which provide significant updates to distance learning standards. Please review if this applies to you. There are very specific requirements for hybrid learning modules as well.
- State Health Commerce System EMT certification look up section has been down for the last few weeks. They have intermittent times that they have been available. The Bureau has no timeline for resolution.

XV. Monroe County – Tim Czapranski

- The County Executive and Health Commissioner teamed up with Erie county to talk about COVID and where we are this year compared to last year.
 - Today in Monroe County: 289 COVID patients in the hospital, 82 in the ICU, last year 184 in the hospital and 33 in the ICU
 It's tough out there.
- The County Executive has announced a program where EMS agencies can get reimbursed up to \$20,000 in unpaid COVID expenses, Tim has sent an email, only six agencies have responded. If you are interested, reach out to Tim Czapranski. There is a quick timeline has to be done by the end of the year.

- Mark did speak with Jean Taylor who mentioned that there was a review of the instructors and their degree of engagement. Some are being invited back as regional faculty, where others are not.
- Mountain Lakes Region shared that they are extremely concerned, they had a regional faculty member that they use a lot who was not invited back, but there was no explanation as to why. The Mountain Lakes Region didn't get notified of any of this from the State, it was all the instructors who shared with the region.

- We have previously sent letters from the Training & Ed Committee as our last regional faculty appointment was >10 years ago. We were told by the State that we do not have any say in this process, but we can have folks send resumes to them for consideration.
- Perhaps we can have Director Greenberg attend our next Council meeting. Brian Weidman to extend an invite to him.
- Mark Philippy, Dr. Doynow and Director Greenberg to meet in the new year with the new Health Commissioner. If you have items that you think is important for discussion, please bring them to Mark.
