- Minor discrepancies in the terms of members for both REMAC & MLREMS that we are trying to reconcile
 - Apologies to Council and REMAC for any confusion this may have caused
 - Will be working with Nicoletta to come up with a new system moving forward
 - Part of the challenge has been mid-year changes, resignations, etc.

<u>Treasurer's Report – Reg Allen</u>

- NYS owes us approximately \$103,000
 - Most of that is the last two filings for the Program Agency
- Has been discussion about contacting our local legislators re: this issue
- Executive Committee wanted to have this body's input on that before action was taken
- Contract with U of R states if we have money, we need to pay
 - At some point, just like in Central New York, we close the doors

- NYS owes two Council vouchers that are about a year old
- Just got paid for October to December of last year
- Still waiting on the January to March payment for this year
- NYS is looking into some shortfalls re: our specialty course renewal long-form application
 - The audit showed that NYS owes us about \$1,200
- We have e-mailed and called Lisa DeLong, Dan Clayton, & Tom Behanna re: these payments
- BEMS cannot see these outstanding payments
 - Lisa DeLong has been trying to help us with the Comptroller's Office
- The next step would be to engage our legislators to help us
- Want to make sure that if we engage our politicians, it's done in a concerted effort that doesn't cut
 anyone short
- Ask those who have good relationships with their legislators or assembly members to guide us
- Need to engage the course sponsors in the region to see if they're owed anything
 - We could combine everything at once to ensure nothing is left out
- Would like to have feedback re: this before the next meeting
