Patient Safety Subcommittee - Elizabeth Murray, DO

- Pediatric Cardiac Arrest/Intubation/Sick Kids is ongoing
 - If the sick kids are being sent to hospitals without a children's hospital, please send the PCR to us as we would like to know about it with our ongoing research.
- Collaborating with RTAC to reduce trauma scene times
 - In Rochester, it takes four hours to move a trauma patient from one hospital to another. We are trying to improve that.
 - When EMS brings a patient to a hospital that's inappropriate, the providers will say that the patient wanted to go there. Is there a way that you can talk with the patient and patient family members to have them understand where they want to go may not be the most appropriate hospital?
 - Sometimes even when you explain to them that they will be transferred anyway despite which hospital you bring them to, but some patients are adamant and won't take no for an answer.
 - The Patient Safety Committee is looking to mitigate this on a case by case basis so that we can find out what the trends are so that we can address it.
- Evaluated several cases regarding inappropriate hospital destinations
 - Working with DPM to develop training to assist providers with determining appropriate destination examples: trauma vs injury, pediatrics that may require ICU, hemophilia

Unity/St. Mary's - Steven Wolfe, MD

- Changes at St. Mary's
 - Psych ED closing as early as the end of August, however no hard and fast date
 - Crisis intervention taking its place, hours TBD, however not 24/7 (hours into the evening). Basically a psychiatric urgent care center.
 - St. Mary's will not be accepting transports from EMS to the crisis intervention center, however, they may be calling to transfer patients out to psychiatric emergency departments.
 - What's the difference in services provided? It will be an office type of setting. You won't have 24/7 capability to care for these patients, no EMS patients.
 - Still 18 and over with the new center? Not determined yet.
 - Psychiatric EDs have been notified about this? No, this is coming from psychiatry and not the Emergency Department
 - What is the call volume of the psychiatric ED? Not very high, handful of patients every 24 hours. So it is assumed that the other facilities can handle the extra volume. The vast majority of these patients are not admitted, they are discharged.
 - How will patients get there if we are not going to transport there? They will have to arrive by their own needs.
 - Where will the patients be going when EMS gets called to transfer these patients? Either RGH or Strong. Some of it will depend on the patient if they are aligned with a certain facility. The number of these patients will be on the lower side. Something to consider psychiatric transports are not emergencies, that will not be paid for by anyone but the facility, has that been taken into account? Ambulance transport is in many cases not a viable solution.
 - If we can facilitate a conversation with the person who is in charge of this transition and the commercial agencies to discuss how everything is going to work, as because of the facility that it is, they cannot call 911.
 - For now, business as usual.
