VI. Chairperson – Mark Philippy

- Muru App for access to collaborative protocols
 - State has been vetting this. There are some further paid options that may allow for additional functionality. Currently, the base program behaves like our current collaborative protocol app.
- The Program Agency has not received any information on the app. We want to be sure to iron out any details and then release an advisory to discuss any details and allow plenty of time for transition. They uploaded regional policies to the app, however they did not check with the region, so we want to make sure everything is correct and that they have the most up to date policies.
- When registering for the app, you do need to put your agency is as the "licensed" agency (i.e. AMR is in their list as National Ambulance).
- Thank you Ahmed for the public announcement sent out regarding the PIER Committee's efforts with Stop the Bleed and EMS Week.

VII. Vice Chair / NEG Report – Tim Kelly

We've amended the by-laws in order to add the REMAC Committee and Legislation into the current council by-laws. Motion to change the current regional council by-laws under the standing committees section, REMAC to remove the requirement of separate by-laws by Sam Tinelli. Seconded by Ahmed Mustafa. Discussion: Regional Patient Safety – change verbiage – this person is appointed by the Regional Medical Director and approved by the REMAC Chair to make it consistent with the Patient Safety Committee policy. Alternates for physicians and voting capability. Originally alternates could vote. We were looking at taking this away to align closer with the SEMAC/SEMSCo Level. Further discussion – why have alternates if we don't allow



them to vote? We are different from the State Council. Any issues with having the alternates vote? No. Thank you everyone for your help with these documents, this is a big step forward in consolidating these documents.

- Thanks to NEQ, Pittsford, Monroe and CHS as they've worked through the home vaccination process.
- Treat in place alternative transportation definitions and approvals are ongoing. These discussions will continue at Council & REMAC.
- Long drops again we are tracking drop times through emsCharts and keeping an eye on things we are still at lower times than pre pandemic times. The hospital is working on opening a geriatric unit within the hospital to help alleviate numbers.
- RRHS Dr. Vernetti has been very responsive with issues, feel free to reach out with concerns.

XI. Program Agency Report – Ben Sensenbach

- Pediatric trach course was this morning. The goal is to build more content for Cypherworx.
- National Stop the Bleed Day is on Thursday 5/20. UR Trauma has partnered with the PIER Committee to create some community based training.
- Peter Brodie ePCR initiatives all states moving to the new system, this will affect outcomes.
- Will be working on updating Agency contacts.
- Fit Teams can be an issue, tied up resources waiting for fit teams. Is there a way to not have EMS called until they are needed? This is an operational issue – EMS Advisory Board is a good place to further discuss this, there are liability concerns and also ties in with our response metrics.
