There is intentionally not an end date written in, so that we do not have to terminate services while we are waiting for the State to approve contracts/payments (i.e. the latest contract wasn't received and signed from the State until January 2023, whereas had we had a date on it, the Program Agency would've stopped work July 2022. There are termination clauses that allow us to end it at any time. If we decide to RFP this, how do we convince other entities that this is good business when we are so behind on payments currently? This is something we will have to think about. This is a best practice, however this is something to consider. Thirty day notice who does this go to? It goes to the Chair. Reference to paper PCR can we remove this? No, as it still is a State deliverable. All in favor? No opposed, no abstentions. Motion passes.

System Medical Director – Ben Sensenbach for Dr. Cushman

- iGel pilot underway. Four agencies participating, any others interested can reach out to Jeremy for details.
- RSI credentialing simulation testing at the end of the month, looking forward to credentialing a few more RSI providers for our region.
- Leave behind naloxone targeted for a few EMS and Fire agencies in Monroe County as part of the HEAL grant, expect to offer up to others as option in April so more to come.
- Dr. Dorsett, Jeremy and others from this region and around the State are working on updating MOLST policy and education given recent changes to the form.
- Handtevy configuration nearly complete, developing educational component. Hopeful to roll out in 2nd quarter of 2023.



- Ben and Jeremy met with FLREMS Counterpart John VanAuker to explore opportunities for collaboration, particularly in areas of performance improvement and patient safety.
- Dr. Dorsett continues to lead two specific efforts on quality: one on stroke care particularly posterior circulation identification and assessment including both UR Medicine and RRHS; and an initiative on "the lift assist" which is engaging multiple partners including primary care to better connect this very high risk population to care and services.
- Dr. Farney has been very busy with a number of patient safety referrals.
- Jeremy is leading a number of revisions to the NYS Collaborative protocols and is working with the UR Trauma Program/RTAC on training surrounding the new trauma triage guidelines.

- Assessed a civil penalty of \$10,000.
- For violations of 10 NYCRR Part 800.3(ap), 800.3(ap)(2), 800.3(ap)(3), 800.15(b) and 800.16(4).
 - "...Patient abuse means any inappropriate and/or offensive physical, sexual or verbal contact or interaction with a patient, irrespective of whether the certificate holder is specifically acting in his/her capacity as an EMT when (s)he engages in the abuse, including but not limited to the following..."
 - "...Psychological abuse means verbal or non-verbal conduct by a certificate holder, directed to a patient, which insults, denigrates, humiliates, shocks, mocks, threatens, harasses, or alarms the patient. Psychological abuse shall not include verbal or non-verbal conduct which has medical or therapeutic purpose or justification..."
 - "...Sexual abuse means conduct by a certificate holder, which subjects a patient to any offense defined in article one hundred thirty, two hundred forty-five of the penal law; or any conduct or communication by a certificate holder that allows, permits, uses or encourages a patient to engage in any act described in two hundred sixtythree of the penal law. Offensive sexual contact or conduct may include, but shall not be limited to, engaging in, or facilitating sexual contact, exposure, performances, photography or any other form of sexual image collection and/or dissemination, irrespective of the patient's receptiveness to the conduct..."
 - "…maintain, at all times, the confidentiality of any and all patient information to which the certificate holder has access concerning patients alive or deceased, including, but not limited to, patient names, conditions, treatments, descriptions, communications, images or other identifying features, irrespective of whether the patient's name is included, which may be transmitted by electronic or other media, except:..."
 - "...has abused a patient, as patient abuse is defined in Section 800.3 of this Part..."

- Part S is out there. The meeting regarding this was very interesting. There is discussion and some displeasure about the wording. It will be in our purview to discuss this body's position on Part S.
- Senate and State Assembly has come up with their objections, which has been published. NYC and Wyoming-Erie REMSCos has come out against Part S as a whole. There are some good parts of this section, however the devil is in the details. The passage of this as written, we go from where we go from making decisions, to where we are in collaboration or consultation. There is important context regarding intent. They may not intend to do things today, but this allows them to do it tomorrow.
- There was money allocated in the budget for creation of districts, however no funds are allocated to the current system. CONs completely pulls the region out of the equation just something to keep in mind. Our timeline at the region is also must quicker that the State timeline especially if they end up having CONs across the entire State. Motion that the Council supports certain elements of Part S of the budget process of the State of New York to include the acceptance of the training, recruitment and retention funding, acceptance of the expanded definition of EMS, accepting mobile integrated healthcare, and open to any other items folks want to consider by Jim Cassin. Discussion. Motion that at the discretion of our Executive Committee that we draft a letter of opposition to Part S on behalf of the Council by Tim Frost. Seconded by Eric Rathfelder. Discussion. All in favor. No opposed, no abstentions. Motion passes.
