State Actions - Ben Sensenbach

- Anthony Canestro
 - Certification has been revoked effective 3/13/23.
 - For violations of 10 NYCRR Part 800.3(ak)
 - "...Criminal offense means, except in exceptional circumstances as determined by the agency, convictions in any jurisdiction for felonies involving murder, manslaughter, assault, sexual abuse, theft, robbery, fraud, embezzlement, drug abuse, or sales of drugs..."
- Stephen Karejwa
 - Certification suspended for one year to become effective 6/13/2023.
 - Shall not renew certification upon expiration
 - Assessed a civil penalty of \$2,000
 - For violations of 10 NYCRR Part 800.16(a)(1), (2) and (3)
 - "...has failed to comply with the requirements of Section 800.15 of this Part..."
 - "...has been negligent in the performance of his/her EMS duties and practice, as negligence is defined in Section 800.3 of this Part..."
 - "...has been incompetent in the performance of his/her EMS duties and practice, as incompetence is defined in Section 800.3 of this Part..."
- Brian Reynolds
 - Certification has been surrendered effective 3/13/23.
 - Assessed a civil penalty of \$2,000. The penalty is stayed based upon the surrender of certification.
 - For violations of 10 NYCRR Part 800.16(a)(8).
 - "...has responded to a call, provided patient care, or driven an ambulance or other emergency medical response vehicle while under the influence of alcohol or any other drug or substance which has affected the certificate holder's physical coordination or intellectual ..."
- Gabriel Oliveras
 - Certification has been surrendered effective 3/20/23.
 - Assessed a civil penalty of \$500.



- For violations of 10 NYCRR Part 800.3(ap)(1).
 - "...Physical abuse means conduct by a certificate holder which causes, by physical contact, physical injury, or serious or protracted impairment of the physical, mental or emotional condition of a patient, or which causes the likelihood of such injury or impairment. Such conduct may include, but shall not be limited to, slapping, hitting, kicking, biting, chocking, smothering, shoving, dragging, pinching, punching, shaking, sitting upon, burning, cutting, strangling, striking, using corporal punishment, or throwing objects at a patient. Physical abuse shall not include reasonable emergency interventions necessary to protect the safety of any ..."

 - Certification has been surrendered effective 1/20/23.
 - For violations of 10 NYCRR Part 800.3(ak)

- iGEL Pilot
 - This is live. We don't expect a large numbers of EMT placed iGels. More importantly for BLS providers to learn capnography and properly ventilate patients. If there are any concerns, please reach out to the Program Agency.
- CARES Updates
 - As soon as the national numbers our published, our CARES report will be shared with this group.
- Handtevy Update
 - The app is ready. We will be taking a train the trainer approach. The dates have been sent out, please have your agencies sign up and contact the Program Agency with questions. If you cannot make any of the dates, please let us know and we will make arrangements to accommodate you.
- Leave Behind Naloxone
 - Expanding in Monroe County to first response agencies. Shipping delays occurred, so this
 may go live as early as this week in targeted zipcodes. This is not an obligation.
