System Medical Director Report - Jeremy Cushman

- NYS Demonstration Project Syringe Epi Kit project
 - o Approved at SEMAC & SEMSCO pending approval from the commissioner's office. Details forthcoming in the next month.
 - o Participation in this pilot project will be completely voluntary, but it will come at a cost for supplies.
 - o In order to train basic EMT's in IM administration, you must be a part of this program.
- Spinal motion restriction
 - o Next few months should become mainstreamed. We will be creating education (working with REMAC & NYACEP) not only for our EMTs, but also for our nursing and physicians.
- CPAP for BLS is on the agenda for REMAC.
 - o It is allowed in the scope of New York, decision to come after REMAC.

Program Agency Report - Benjamin Sensenbach

- Quarterly Reports
 - o All reports and vouchers have been turned into NYS
- emsCharts
 - Development people work group for several days in June to implement our regional data dictionary.
- Preceptor training
 - O Class in May that was full, so based on that, we scheduled a class for June. Please let us know if your agency is in need of more preceptors, as we hold these classes based on request.
- Naloxone
 - o Our quarterly report has been sent to the state.
 - o We had 40 doses used in the first quarter of 2015.
 - We can see from these numbers that it's not just a city problem.
 - With the 2014 mortality data show that white suburban men that are generally 30-40s.

- Collaborative stroke training update
 - o Will do more work on this initiative when we know it's a "go" from the Program Agency. Group will move forward when all stroke centers are committed.
- CME Matrix
 - o Hoping for MLREMS support with the understanding it's a "living document" in case changes need to be made when AHA updates courses or additional courses are added.
 - o Motion to approve, motion passes.
- CIC/CLI/PWI contact list
 - o Received data from state, first version complete. Working on adding expiration dates for people who are CLI/CIC.
 - o Plan is to have Program Agency create a distribution list with these emails, send out an initial email to verify the information is correct, then request the CICs add additional PWIs they use that aren't on the list.

 - o Discussion Can we make an agency commit to a certain number of trainings per year (2 Basic)
 - We are able to write to the state if an agency does not meet their requirements.
 - Maybe not put a number on it, as certain course sponsors only offer classes when they need one, yet they need to hold a course sponsorship (i.e. Rochester Fire)
 - Motion to recommend Henrietta Ambulance as a course sponsor? Seconded. Abstentions: R. Allen & J. Cushman. Motion passed.
